Grundtvig subprogramme

- Adult education support programme with the aim:
 - To respond to the educational challenge of an ageing population in Europe
 - To help provide adults with pathways to improving their knowledge and competences
- Participants – adult learners and organisations providing adult education
- Responsible organisation for the programme management – State Education Development Agency

Visits & exchanges	Work-related visit to improve practical teaching / coaching / counselling / management skills etc.	Persons in adult education sector
Assistantships	Training to enhance knowledge of adult education systems and to improve professional competences.	Persons in adult education sector

Grundtvig in Latvia

- Highly appreciated by adult education organisations in Latvia
- Profile of the organisations – different NGO's, educational centres, universities
- Level of activity – high level of submitted applications in almost all actions, funded – less than 50%

What will follow from 2014?

- November 2011 proposal of EC for new education support programme - «Erasmus for All» for the period 2014-2020
- Aim of the programme – achieve targets set in «Europe 2020» - smart, inclusive and sustainable growth of EU
- «Erasmus for All» continues LLP aims – enhance international cooperation in the lifelong learning field

What we know about «Erasmus for All»

- **November – December 2012** – EC proposal for regulation “Erasmus for All” ([177188/11 + ADD 1 – 6](#)), submitted to EP Education and culture committee
- **May 2012** – discussions in European Council, support of EU education ministers to the EC proposal
- **July – November 2012** - discussions in European Parliament Educational and culture committee, 273 proposals from members (name of the programme- “[Y](#)outh[E](#)ducation[S](#)port[Europe](#)”, keep the names of the sub programmes)
- **2013** – continues consultations among European Council, Parliament and EC.

Planned structure and actions

Three main actions(Key Actions):

- **Learning Mobility– KA1.** ~ 65% of total budget;
- **Cooperation for innovation and good practices– KA2.** ~ 25% of total budget;
- **Support for policy reforms– KA3.** ~ 4% of total budget.

Learning Mobility – K1

- Staff mobility
- Aim - improve the level of key competences and skills, quality improvement and innovation, modernisation of the education systems
- Supported activities - structured courses or training events, work placement in a workplace/enterprise or in a teaching/training institution, job shadowing/ observation period

Cooperation for innovation and good practices K2

- Strategic partnerships
- **Aim** - To support the modernisation of adult education organisations by improving the quality of teaching and learning through the transfer and implementation of good quality and innovative practices
- **Activities** - exchange experiences and best practices, development, testing and validation of new curricula, teaching methods or innovative pedagogical approaches inter alia vis-à-vis modern technologies, innovative guidance and counselling tools

Main administrative changes

- Proposals submitted by legal entities
- EPALE – partner search and information exchange portal for adult education
- No real costs
- More emphasis to the project results dissemination and sustainability, impact to the educational system and lifelong learning

When the «Erasmus for All» will be adopted?

- Adoption of the programme - September 2013
- Call for proposals – November 2013
